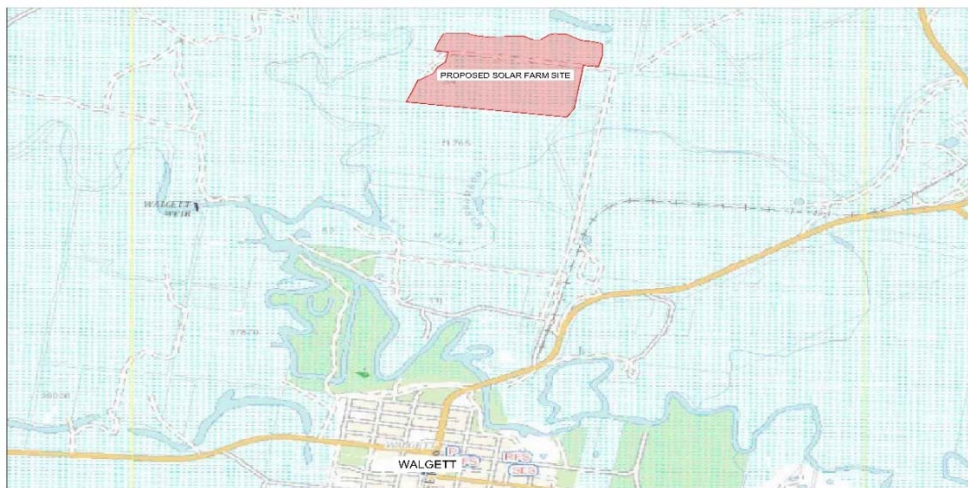
## EPURON ISLAND GP

Epuron is an Australian-owned renewable energy development company established in 2003. Epuron Island GP is proposing a large scale solar farm at Walgett. The farm will generate renewable electricity which will feed into the national electricity grid and use standard, flat solar photovoltaic (PV) modules. These are the same type of modules commonly used on residential rooftops. The modules would either be 'fixed' mounted or 'tracking'. Tracking frames move every minute or so in order to ensure that the modules are always facing the sun.

Whilst detailed engineering and grid connection studies are yet to be completed, the solar farm is expected to have a generating capacity of approximately 35 MW and occupy an area of up to 90 ha.

The proposed development site is located approximately 5 km north of town.



## COMMUNITY ENGAGEMENT

The solar farm is a development that requires consent and approval under NSW planning legislation. To this end a range of environmental impact assessment studies are about to commence.

The Walgett community's input to this assessment and approvals process is important to Epuron. It will help us ensure that local issues are well understood and considered in progressing the project.

Once submitted, our development application will be available to the public on the NSW Department of Planning and Environment website and public submissions will be sought.
