

## Project Update

Located about 10 km east of Muswellbrook, the proposed Bowmans Creek Wind Farm would involve the construction, operation, maintenance and eventually the decommissioning of up to 80 wind turbines (see proposed layout on page 2).

## Project EIS Underway

Earlier this year Epuron submitted a Scoping Report to the NSW Department of Planning, Industry and Environment (DPIE), describing the Bowmans Creek Wind Farm (project) and subsequently were issued Secretary's Environmental Assessment Requirements (SEARs).

Epuron has engaged local independent environmental consultants Hansen Bailey to complete the Environmental Impact Statement (EIS) for the project in accordance with the SEARs.

Specialist consultants have been undertaking various studies required for the EIS including impact assessments for: Visual Amenity, Construction and Operational Noise, Ecology, Heritage and Transportation of equipment for construction.

## Community Information Sessions

Epuron will be hosting another 4 information sessions to provide an update on the project and continue to collect feedback from the community to ensure any identified issues are addressed in the EIS. 
